## For the fifth time: European recognition of excellence for the 'European Master in Law and Economics'

The EMLE program receives 2,8 Million Euro funding for the next 6 years, thereby securing an unprecedent 24 years of continuous funding from the Erasmus Mundus:Erasmus+ programme.

The international Master's Programme "European Master in Law and Economics" (EMLE) has been awarded for the fifth time the prestigious Erasmus Mundus:Erasmus+ grant for Erasmus Mundus Joint Master (EMJM) Programmes. The EMLE Programme was included in the <u>catalogue</u> of sponsored programmes since the beginning of this funding action in 2004. This is a unique achievement. With the current grant, the EMLE will be able to award 20 scholarships for European students, 40 scholarships for non-European students and up to 30 additional scholarships for students from countries who are considered under EU Funding 'Heading 6' by the European Commission.

## About the EMLE consortium:

The EMLE consortium is comprised of 9 academic institutions: 7 European and 2 non-European partners. The Partners are the Aix-Marseille University (France), the University Pompeu Fabra (Barcelona, Spain), the University of Ghent (Belgium), University of Haifa (Israel), the University of Hamburg (Germany), the Indira Gandhi Institute of Development Research in Mumbai (India), LUMSA University in Rome (Italy), the Erasmus University Rotterdam (the Netherlands), and the Warsaw School of Economics (Poland) The directorship of the consortium currently lies at the Erasmus University Rotterdam. The consortium has additional academic and non-academic associate partners in almost all continents of the world. ## The EMLE programme:

The EMLE is a 1-year, 60 ECTS master programme for students with educational background or working experience in the fields of law and/or economics. In small, international classes, students approach the economic analysis of law of different fields, gaining a profound basis in the first term of the programme. In the second term, students can start a specialization track, completed with two additional courses and a master's thesis in the third term. The following specializations are offered: 1) Economic Analysis of Public and International Law, 2) Economic Analysis of Markets, Corporations and Regulators, and 3) Economic Analysis of Intellectual Property and Innovation. At the heart of the programme lies its mobility scheme: students study at two or three different EMLE Partner Universities. Besides a profound knowledge of the economic analysis of law, students will be trained internationally and interdisciplinary and gain insight into the labour market through the network of EMLE associate partners from the different fields of practice.
