The position in accordance with Section 28 subsection 1 of the Hamburg higher education act (Hamburgisches Hochschulgesetz, HmbHG) commences on 1 January 2021.

This is a fixed term contract in accordance with Section 2 of the academic fixed-term labor contract act (Wissenschaftszeitvertragsgesetz, WissZeitVG). The initial fixed term is three years. The position calls for 50% of standard work hours per week.*

RESPONSIBILITIES:

Research associates will be expected primarily to teach and conduct research. The research associate will also have the opportunity to pursue further academic qualifications, in particular a doctoral dissertation. At least one-third of set working hours will be made available for the research associate's own academic work.

SPECIFIC DUTIES:

The research associate will work with Professor Georg Ringe at the Institute of Law & Economics. This will include research, from an interdisciplinary and economic perspective, on issues of financial regulation, corporate governance, and capital markets law. A special focus will be on questions concerning digitalisation and sustainability in these fields. The research associate is also expected to contribute to the Institute's teaching curriculum with a responsibility of 2.25h per week during term time.

REQUIREMENTS:

A university degree in a relevant field. Preferred in either law, economics or business administration. An excellent command of English is essential. We expect applications from a strong candidate with an interest in the subject areas mentioned above. Prior experience or qualifications in the specific field are however not a precondition for applying.
