**Georg Ringe** is Director of the Institute of Law & Economics at the University of Hamburg and Visiting Professor at the University of Oxford, Faculty of Law. His research focuses on questions of corporate law, capital markets, and financial regulation, from an interdisciplinary and comparative perspective. He is a Research Member with the European Corporate Governance Institute, Fellow at the European Banking Institute, and co-editor of the Journal of Financial Regulation.

**Stefan Voigt** has been Director of the Institute of Law and Economics since 2009. He is a fellow of the CESifo Group in Munich and affiliated with the International Centre for Economic Research (ICER) in Turin. His research focuses on the economic effects of alternative constitutional rules and the consequences of different judicial structures. He is copublisher of the Review of Law and Economics and member of editorial boards of journals such as Public Choice, Constitutional Political Economy, and the Review of Austrian Economics.
