Pending approval of external funding Universität Hamburg invites applications for two Research Associates for the project “**Law, Finance and Technology**” in accordance with Section 28 subsection 3 of the Hamburg higher education act (Hamburgisches Hochschulgesetz, HmbHG). **The two positions commence on 01.01.2019<sup>1</sup>.**

They are remunerated at the salary level TV-L 13 and calls for 50 % of standard work hours per week\*.

The fixed-term nature of the contracts are based upon Section 2 of the academic fixed-term labor contract act (Wissenschaftszeitvertragsgesetz, WissZeitVG). The term is fixed for a period of 3 years.

The University aims to increase the number of women in research and teaching and explicitly encourages women to apply. Equally qualified female applicants will receive preference in accordance with the Hamburg act on gender equality (Hamburgisches Gleichstellungsgesetz, HmbGleiG).

#### **Responsibilities:**

Duties include academic services in the project named above. Research associates can also pursue independent research and further academic qualifications.

#### **Specific Duties:**

The research associates will work with Professor Georg Ringe at the Institute of Law & Economics. This will include research, from an interdisciplinary and economic perspective, on issues of financial regulation, comparative corporate governance, and capital markets law. The two positions will be affiliated with the new research project “Law, Finance and Technology”.

#### **Requirements:**

A university degree in a relevant field preferred in either law, economics or business administration. An excellent command of English is essential. We expect applications from strong candidates with an interest in the subject areas mentioned above. Prior experience or qualifications in the specific field are however not a precondition for applying.

Severely disabled applicants will receive preference over equally qualified non-disabled applicants.
