"We are all negligent and afraid of renewal" (Al-Tayyib<sup>1</sup>, 2017)

The fast growing modern society and continuous misuse of religious notions pushed governments in Muslim countries to renew the religious discourse "tajdeed". However, there is no consensus on the necessary changes and how they are to be implemented.

For example, the Tunisian parliament is currently discussing a draft bill of a new inheritance law, which no longer relies on Sharia and the Quran. The Egyptian President Abdel Fattah El Sisi called for renewing the religious discourse and modifying legal rules that misinterpret the Quran and Sunnah.

In this workshop, we will discuss the challenges and opportunities of amending legal texts based on Sharia in Muslim countries. The economic, legal and the political aspects will be addressed.
