# **CESL Summer School: The Europe Experience**

The second Summer School of the China-EU School of Law (CESL) will be held from 16<sup>th</sup> August to 3<sup>th</sup> September 2010 in Hamburg. Students of the CESL Master of Law Programme as well as PhD students will have the opportunity to gain deeper insights into the German and European legal systems. They will take a look behind the scenes of the main actors in the field, such as the Federal Parliament of Germany (Deutscher Bundestag), the European Parliament, and the European Commission.
