SYMPOSIUM REFLECTS ON INTERNATIONAL TRADE LAW



The ties between China and Europe have grown strong: Today, the European Union is the People's Republic of China's largest trading partner, and China is the EU's second largest trade partner after the United States of America. Ratified by more than eighty states worldwide – since 2013, including China—, the United Nations Convention on Contracts for the International Sale of Goods (CISG) governs a significant proportion of Sino-European trade. However, there are additional rules and regulations. Moreover, trade relations between Europe and China are constantly evolving. As a consequence, very often actors do not know the other legal system and discover it only in case of litigation.

The "International sale of goods" symposium aims to provide a comparative legal analysis of international sales law. It will also assess consequences of European rules for Chinese companies and of Chinese rules for European companies.

The symposium takes place on 20 and 21 June 2016 at the China University of Political Science and Law in room B209, Keyan Building, 25, Xitucheng Road, Haidian District, Beijing. It is jointly organised by the University of Strasbourg and the China-EU School of Law at the China University of Political Science and Law. This conference is the fifth symposium of the CESL International Symposium Series.
